Our Mission

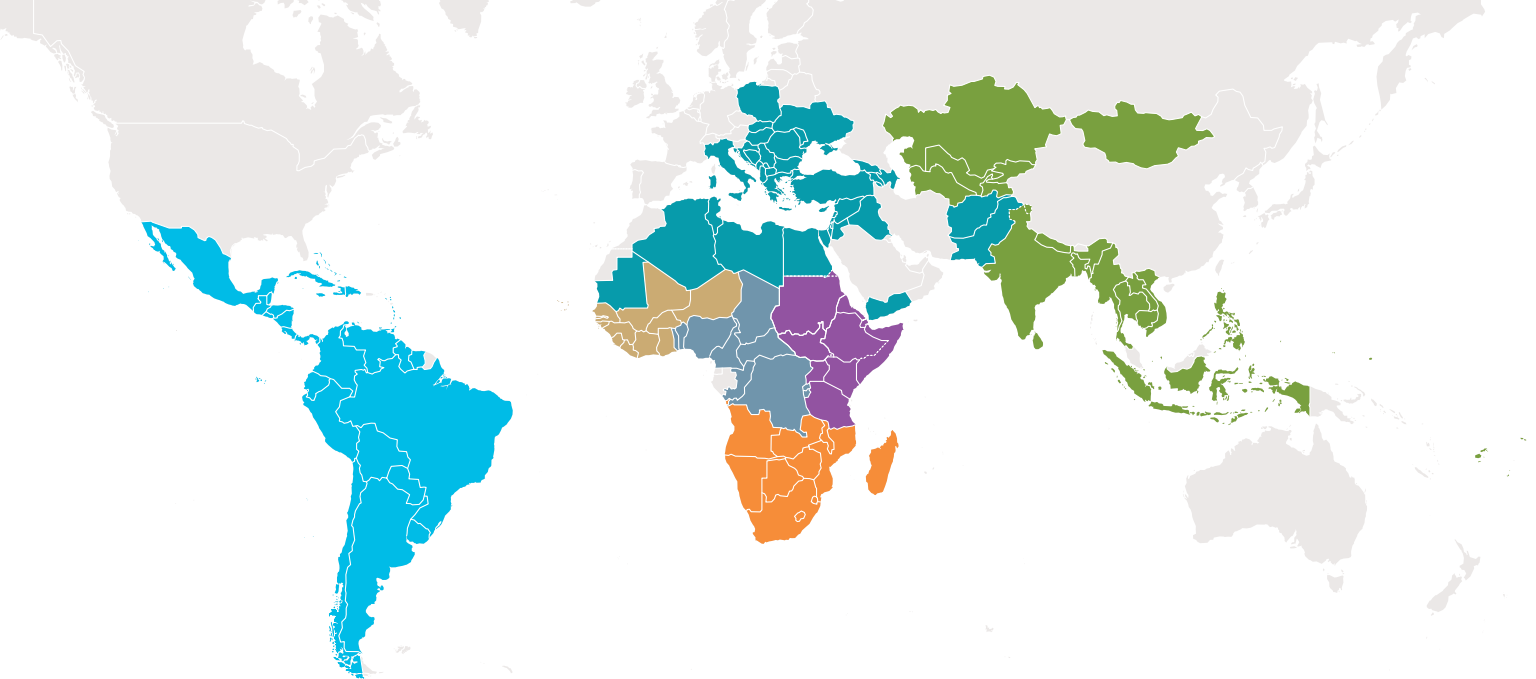

In Nigeria’s Lake Chad Region—where prolonged conflict has affected thousands of people—the Stabilization and Reconciliation project, or STaR, is paving the way for peace and stability. The CRS project, funded by the KfW Development Bank, helps nearly 60,000 people access employment opportunities and basic services like water, health care and education. It also trains community members to act as peace ambassadors, preventing conflict before it even begins.

The STaR project stresses the importance of social cohesion, promoting conflict resolution and inclusion for marginalized people. Peace ambassadors in Shelleng, a farming community in Adamawa State, work toward unity—and help others find it as well.

When two farmers, Ayuba Kondokwara and Aminu Gamanayilu, found themselves in a dispute, Silas Titus, a trained peace ambassador, facilitated a resolution between them. “It’s very good to have this kind of system,” Silas says. “The role we play, preaching the messages of peace, goes to promote peace and unity in the community.”

“I am happy with the way the ambassadors helped me resolve the conflict,” says Ayuba. “This issue would have escalated to our family and friends if not for the intervention of the peace ambassador. I am grateful.”

Education Gives Hope to Refugee Children in Lebanon

In Lebanon—a country that continues to experience much conflict—the Good Shepherd Sisters’ education center inspires hope for refugee families.

Muntaha al-Hassan was eight months pregnant with her daughter Sidra when their family fled their home in Syria after an airstrike reduced their house to rubble. In 2016, they crossed into Lebanon. Muntaha’s family eventually settled in Deir al Ahmar, a small farming village surrounded by vineyards in the Bekaa Valley, where Sidra was born under a canvas tent.

None of the children were able to attend public school in Lebanon, and the process to register as a refugee family was difficult. Two years after arriving in the country, Muntaha discovered the Good Shepherd Sisters’ education center, a CRS supported school in the village. Run by Sister Rita Hadshiti, the center provides education to Syrian children unable to otherwise attend public schools. In 2024, 210 Syrian children were enrolled and taught by a dedicated team of teachers.

“Now, what makes me happiest is watching my youngest, my only daughter, go to school,” Muntaha says. “She started in first grade and will be able to complete her education here. She’s my hope for the future.”

“Without water, there are no human beings. Water is critical for human survival.” Mawuli Lumor, the acting director of water resources planning and management for Ghana's Water Resources Commission, shares this universal truth while discussing a new integrated watershed protection program in Ghana's Northern Region. A Catholic Relief Services project there—in partnership with Ghana's Water Resources Commission and other local organizations—helps communities access clean water and adapt to changing climates.

Adam Abdul-Latif, a local farmer, is strengthening his livelihood by participating in the project. In addition to learning climate-resilient farming practices, Adam and other farmers are restoring Ghana's White Volta River Basin by planting trees and other vegetation along the riverbank. The plants help prevent flooding, protecting farms and homes. The project also provides the farmers with access to pumps that draw water for their fields—especially critical during the increasingly long dry seasons.

“This year, for about two to three months, we didn't get rain,” Adam says. “Most farmers didn't get any crops. If things continue with the support of government and other organizations, I think in our future there will be better living. With education, the future will be good.”

Providing Healthy Meals for Children in Laos

In the heart of a school’s bustling kitchen, the aroma of freshly cooked rice porridge fills the air as Hongkham Phengsaphone prepares lunch for more than 100 students from her local village in Savannakhet province in southern Laos.

Hongkham’s passion for cooking led her to volunteer at her children’s school kitchen to cook school lunches offered through Catholic Relief Services’ LEAPS project—Learning and Engaging All in Primary School. Using staple foods like rice and lentils grown by American farmers, each meal is carefully prepared and served with fresh vegetables harvested daily from the school garden.

Implemented by CRS in partnership with the Ministry of Education and Sports in Laos, the LEAPS project ensures students receive balanced and nourishing meals, which are vital for their growth and development.

The third phase of LEAPS addresses food insecurity by providing more than 30,000 students across 302 schools in Savannakhet province with access to nutritious lunches. Through effective collaboration between government entities and local communities, the LEAPS project demonstrates a commitment to supporting the health and future opportunities of Laos’ children.

Hongkham’s dedication in the kitchen has not gone unnoticed. “Parents thank me for helping the school and cooking for their children. I’m happy to support the children and the community,” she says. “Most of the children love the rice porridge. Every time they eat it, they are happy and joyful, and compliment me, saying ‘it’s so good.’ Some even come back for seconds.”

In a remote, rural community in El Salvador, brothers John and Esteban Rodríguez* run a thriving vegetable business. Starting a business wasn’t initially on their radar. Like so many others in their community, John, 19, and Esteban, 22, experienced family separation when their parents migrated for work. The young men had intended to join their parents, as limited access to education and lack of employment opportunities gave them few choices for success in their hometown.

“Most young people choose to emigrate abroad,” says John. “Due to the lack of economic resources, they do not continue studying. There is no other option.”

Several programs changed John and Esteban’s plan. First, two local El Salvador organizations gave them a donation to build a greenhouse. John and Esteban then joined a CRS project called Youth Creating Alternatives to Migration funded by The Church of Jesus Christ of Latter-day Saints, where they learned sustainable agriculture practices and entrepreneurship.

The brothers were able to apply their new knowledge and business skills to start and grow their business. Despite the region’s high temperatures and degraded soil, they produce high-quality chiles, tomatoes and cucumbers, which they sell near their community in San Antonio de las Iglesias. With their parents’ support, the brothers now envision a prosperous life together in their home country, something that seemed impossible for them in the past.

Confronting Global Poverty Through Collective Action

As God’s children, we should all have the opportunity to thrive. Instead, millions struggle to survive—afflicted by poverty, hunger, conflict and other affronts to human dignity. CRS is committed to transforming this reality by bringing lifesaving and life-affirming assistance to the world’s most vulnerable people. But this work would not be possible without addressing systems and structures that impact global poverty.

Our advocacy work in the United States seeks solutions to global poverty and its root causes. We leverage on-the-ground expertise, Church teaching and a network of supporters to advocate for laws that can help our global family navigate environmental challenges, such as natural disasters like drought and storms, and human-made challenges, including social inequities, conflicts and health crises.

Building bipartisan support is at the heart of our approach. It starts with policy analysis rooted in our programming. We then identify legislative and other policy priorities that CRS staff and supporters advocate for. As in previous years, this work has helped shape key policy outcomes that affect millions of lives.

Whether through face-to-face meetings with legislators, personalized emails or phone calls, when staff and supporters share stories about CRS’ work and why international relief and development issues are important, it increases our credibility and influence with decision-makers. These relationships are the foundation for advancing our goals and creating transformational change.

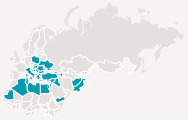

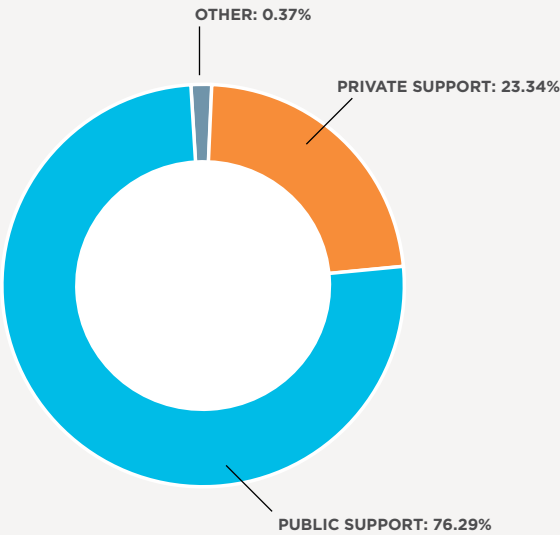

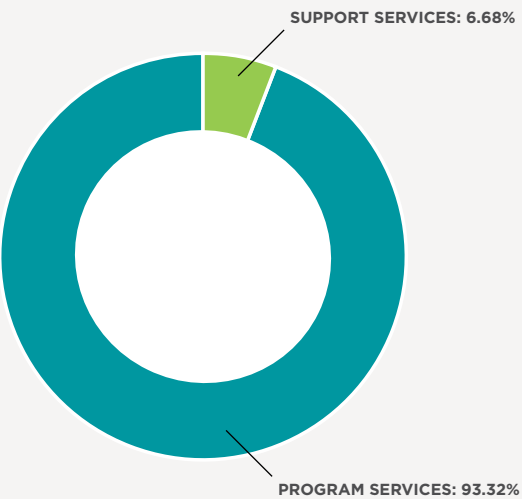
