## What is a WASH in Schools Action Planning?

## What is The Purpose of WASH in Schools Action Planning?

the water, sanitation, and hygiene needs of a school community. It serves as a roadmap for

implementing comprehensive WASH interventions that promote health, well-being, and optimal

learning outcomes for students.

□ The main purposes of WASH in Schools Action Planning are:

## What is The Purpose of WASH in Schools Action Planning? – Cont.

- □ Stakeholder Engagement: To actively involve and engage all relevant stakeholders, such as teachers, school administrators, parents, students, community members, and local authorities, in the planning and implementation process to ensure ownership, collaboration, and sustainability.
- □ Monitoring and Evaluation: To establish mechanisms for regular monitoring and evaluation of the action plan's progress, effectiveness, and impact, and to make necessary adjustments and improvements based on the findings.





## Importance of WASH in Schools Action Planning?

**Improved Health and Hygiene:** Effective action planning ensures the implementation of adequate

water, sanitation, and hygiene facilities in schools. This promotes good hygiene practices, such as

handwashing with soap, proper sanitation, and access to safe drinking water. It helps prevent the

## Importance of WASH in Schools Action Planning? – Cont.

public health.

## **Assessing Current Status**

## **Setting Objectives and Goals**

## Setting Objectives and Goals – Cont.

#### C. Aligning Objectives with National or International WASH Guidelines

□ Referring to national or international standards and guidelines for WASH in schools.

□ Ensuring that the objectives are in line with the recommended practices and requirements.

Adapting and contextualizing the guidelines to the specific needs and conditions of the school.

Setting clear objectives and goals provides a roadmap for WASH action planning. It enables schools to

focus their efforts, allocate resources effectively, and measure their progress towards improving

WASH practices. Alignment with national or international guidelines ensures that the objectives are

based on recognized best practices, promoting the provision of safe and hygienic environments for

students and staff.





## **Developing Strategies and Action Steps**
